**GUESTS:** Dr. Jennifer Rager-Kay, Robin Kauffman. Dr. Jennifer Rager-Kay discussed her intentions on running for PA State Representative office. Robin reviewed the Christmas light decorations and hero banners.

**MINUTES, BILLS and TREASURERS REPORT:** Will motioned to approve the minutes; Max second, with a roll call vote-unanimous yes-motion carried. Ron motioned to approve the bills; Will second, with a roll call vote-unanimous yes-motion carried. Lori motioned to approve the treasurer's report; Ron second, with a roll call vote-unanimous yes-motion carried.

Will motioned to approve the exoneration of Kirk A Drummond; Max second, with a roll call vote-unanimous yes-motion carried. LST Deposits: Fines \$14.15, LST \$169.08, Total = \$183.23. Payroll: BMA Sewer (reimbursement for Phil's payroll) \$676.60, BMA Water (reimbursement for Phil's payroll) \$1,612.40, Total = \$2,289.00.
