Tina Hackenburg spoke to the Council on her concerns of actions being seen in the playground area. <u>MINUTES, BILLS and TREASURER'S REPORT</u>: Denny motion to approve the minutes; Ron second, with a roll call vote-unanimous yes-motion carried. Will motioned to pay the bills; Denny second, with a roll call vote-unanimous yes-motion carried. Ron motioned to approve the treasurer's report; Linda second, with a roll call vote-unanimous yes-motion carried.

OLD BUSINESS: None.

ATTORNEY'S REPORT: None.

MAYOR'S REPORT: Mayor Hollenbach reviewed the Police Report, reported on properties and residents concerns. Mayor Hollenbach explained to Council that PENN DOT, since 522 is a state road (Market Street) needs a Resolution passed in order to hang Banners and Christmas Lights on Market Street. Ron motioned to approve a Resolution to be passed allowing for the banners to be hung on Market Street; Max second, with a roll call vote-unanimous yes-motion carried. The Mayor has gotten one Fire Co., sign permit for the east end of town, and the west end of town was not approved.

**BOROUGH SUPERVISOR'S REPORT**: Phil reported that they did their normal checking of the streets. They took off all winter equipment from the trucks. Phil is still looking for a bucket truck. Fixed the faucet in the Vesta Coleman room, put up new basketball nets, fixed the dugout roofs. The water project is under way.

Payroll Deposits: BMA Sewer (reimbursement for Phil's payroll) \$4,364.09, BMA Water (reimbursement for Phil's payroll) \$3,473.22; Total = \$7,837.31.

**NEW BUSINESS:** Lori asked if the Council was going to donate to the War Memorial this year. Denny motioned to donate \$1,000.00 to the War Memorial; Will second, with a roll call vote-unanimous yes-motion carried.
